## **BLOCK PARTY RULES & REGULATONS**

Names, addresses and phone numbers of all neighbors participating in the street closure must be provided. Their signature indicates consent to the proposed block party, street closure and acknowledgement that all residents and their guest shall adhere to all applicable laws, regulations, and ordinances, including but not limited to the noise ordinances and Hold Harmless Agreement.

- 1. All block parties subject to Mayor, Council and Police approval.
- 2. The Chairperson is responsible for the block party, they'll answer for all concerns and violations during block party.
- 3. The **COMPLETE** application with all applicable signatures due 3 weeks prior to party date. Submission of application doesn't guarantee approval.
- 4. Must have 75% of the block residents' signatures and phone numbers.
- 5. No block party will be conducted in such a manner as to interfere with the safe passage of emergency vehicles. **FIRE HYDRANTS MUST NOT BE BLOCKED!**
- 6. Underage drinking is strictly prohibited by law.
- 7. Music must be kept at tolerable levels.
- 8. Attendees are responsible for all clean-up.
- 9. Applicant must be a resident of the block that is being used.
- 10. Chairperson must make sure street is clear of all debris and barricades removed within an hour of end of party on application.
- 11. No breaking the surface of streets, sidewalks curbs, driveway aprons etc. for tent poles or the like is permitted. These actions are strictly prohibited and cause for issuance of a summons.
- 12. Must provide a 1-day Insurance Certificate.
