**NOTICE OF PUBLIC HEARING
PROPOSED AMENDMENT TO THE
MONMOUTH COUNTY SOLID WASTE PLAN**

In accordance with the requirements of the New Jersey Solid Waste Management Act (N.J.S.A. 13:1E-1 et seq), the Monmouth County Board of Chosen Freeholders will be holding a public hearing on Tuesday, November 21, 2017 at 1:00 p.m., or as soon thereafter as the matter may be heard, at the Monmouth County Hall of Records, Freeholders Meeting Room, second floor, One East Main Street, in Freehold, New Jersey.

The purpose of this hearing is to hear persons interested in, or who would be affected by, a proposed amendment (Amendment 2017-05) to the Monmouth County Solid Waste Management Plan entitled "Increase in Volume of Class 'A' Materials at Mazza Recycling Services, Ltd., 3230 Shafto Road (lot 26.01, Block 145) in Tinton Falls," which would allow the expansion of Mazza Recycling Services, Ltd. to accept 300 tons per day of Class "A" materials (including cans, bottles, and fiber), which will be an increase from the present 110 tons per day, that is currently permitted in the Monmouth County Solid Waste Management Plan. The Mazza facility comprises 52.05 acres of land at the above listed address. The facilities include a Class "B" recycling facility and a solid waste transfer station in addition to this Class "A" material facility (transfer area). No Class "A" materials are or will be processed onsite, as they are transferred to another facility out of the area for processing. The hours by which the Mazza Recycling Services, Ltd. facility is allowed to accept materials is from 6:00 am to 5:00 pm Monday through Friday and from 6:00 am to 1:00 pm on Saturdays (from May 1st through September 15th) and 7:00 am to 4:00 pm Monday through Friday and on Saturdays from 7:00 am to 1:00 pm (from September 16 through April 30). Any person may appear at this hearing in person, or by agent, or by attorney. As part of this amendment, Mazza Recycling Services, Ltd. will be entering into a developer's agreement with Monmouth County to properly signalize the intersection of the "Mazza Driveway" and Shafto Road (County Highway 547).

A summary of this proposed amendment has been distributed to each municipality in Monmouth County via electronic mail, and have also been distributed to each branch of the Monmouth County Library System. Copies are additionally available on request to the Monmouth County Solid Waste Coordinator at the Monmouth County Reclamation Center. Any written comments should be directed to the Solid Waste Coordinator, c/o Monmouth County Reclamation Center, 6000 Asbury Avenue, Tinton Falls, New Jersey, 07753. Comments received on or before November 21, 2017 will be appended to the official Public Hearing Transcript that will be sent to the NJDEP Commissioner.
