Bidders interested in obtaining hard copies of the documents in person from the office must make an appointment with Patti Sirico. Bidders will be furnished with a hard copy of the Contract Documents upon proper notice and payment of a non-refundable charge of One Hundred Dollars (\$100.00) payable to "T&M Associates" at the offices of T&M Associates to defray the cost thereof.

The successful Bidder shall be required to comply with the applicable statutory requirements of the Contract Documents and Plans which include all of the following: (i) N.J.A.C. 17:27; (ii) N.J.S.A. 10:5-31 et seq.; (iii) Business Registrations (N.J.S.A. 52:32-44); (iv) Prevailing Wage Act (N.J.S.A. 34:11-56.25, et seq.); (v) Public Work Contractor Registration (N.J.S.A. 34:11-56.48); and (vi) Affirmative Action Requirements (N.J.S.A. 10:5-1, et seq.); and any other legal requirements applicable to this Project.

The Borough of Union Beach intends to award this Project to the lowest responsible and responsive Bidder in accordance with applicable law. The Borough of Union Beach reserves the right to reject any and all Bid Packets to the extent permitted by law. An award will be made, or Bid Packets will be rejected within sixty (60) Calendar Days after the opening of the Bid Packets, during which time the Bid Packets shall be irrevocable and unavailable to withdraw by Bidders, unless otherwise extended in the Contract Documents.
